- (6) The NO OBJECTION CERTIFICATE along with the conditions Subject to which the same has been issued should be exhibited in a conspicuous place in the Champers of the Principal/Head Master/ Head Mistress, for the benefit of general public.
- (7) For starting the pre-primary school (Nursery/LKG/UKG etc.,) the management shall obtain prior permission by registering the same in accordance with the Karnataka Educational Institutions Classification and Registration) Rules, 1997.
- (8) Any other conditions that may be imposed in future.
- (9) Government of Karnataka may take action to withdraw this No Objection Certificate in case any of the conditions is violated.
